This group was tasked with: **How our "unique and united" pastoral council(s) will collaborate and guide St. Malachi's and St. Patrick's into a vibrant future.**

We also needed to take into consideration these points from Fr. Gurnick.

- a. create models based on Diocesan guidelines
- b. reduce the number of meetings the pastor attends
- c. create a model for communal meetings open to the people of both St. Malachi's and St. Patrick's
- d. establish a method for each organization to submit regular reports of projects, plans and activities.

Research included: We studied the existing guidelines of both parish councils. We also obtained the Parish Pastoral Council Policy from the Diocese of Cleveland, "Christ Calls Us Together," dated November 1990. Available at the QR code here.



The Diocese of Cleveland Parish Pastoral Council Policy outlines expectations into ten norms:

- 1. Every parish in the Diocese of Cleveland (DOC) is to have a Parish Pastoral Council (PPC).
- 2. PPC is a consultative body which makes recommendations to the pastor.
- 3. The Pastor is to preside over the PPC.
- 4. The pastor is to consult ppc on matters of major pastoral concern.
- 5. The purpose of PPC is to promote the spiritual growth of the parish community and to plan ways for the parish to carry out the mission of the Church. NORM 6: The members of PPC represent the interests and pastoral needs of the parish community.
- 6. The members of PPC represent the interests and pastoral needs of the parish community.
- 7. Membership on the PPC, except for those who are members by reason of their office, is to be determined in an appropriate manner which allows for the participation of the parish community.
- 8. Members of PPC, except for those who are members by reason of their office, shall have a limited term.
- 9. PPC is to select a chairperson and other officers from among its members.
- 10. PPC works with existing parish groups and forms new groups as needed to promote the spiritual growth of the parish and foster the mission of the Church.

We have concluded that:

- a) The Diocesan guidelines are clear & concise and make allowances for small parishes.
- b) St. Malachi guidelines closely resemble the Diocesan norms.
- c) St. Patrick guidelines address most of the norms, but not clearly. It is a model that relies heavily on staff involvement. It should also be noted that it is difficult to recruit parishioners at St. Patrick's to fill vacancies on council.

The workgroup researched what other parishes have developed when they joined together, and the members hoped to find a best practice model. We found many different terms were used to describe coming together, such as "twinning" or "quasi-parish". We spoke to fellow Catholics in seven parishes. Unfortunately, none of these entities had council guidelines they could share. However, we did find:

- a. St. John-St. Paul Catholic Collaborative in Boston. They publish their guidelines and meeting minutes on their website.
- b. We had been given the Canadian guidelines followed by the author of the book <u>Divine Renovation</u>.
- c. We were directed to www.pastoralcouncils.com by Dave DeLambo, former Associate Director of the Diocese of Cleveland Pastoral Planning Office. There we found a sample set of guidelines written by Mark Fischer.

We concluded the only items not identified as norms in the Cleveland document are the relationship between pastoral council and finance council, communication with the parish community, and decision-making process. Therefore, we created our own best practice model adopting Cleveland's ten norms and adding these three critical areas.

To analyze these six models, Diocese of Cleveland, St. Malachi's, St. Patrick's, Boston Collaborative, Canada's, and Mark Fischer's against our new model, we created a spreadsheet. We searched for language that came close to each norm. Each model has its own column. You can access that spreadsheet here [QR].

A column for pros and cons for each model's norm is contained on the spreadsheet. We have also listed a "Best Practice" for each norm that takes into account all of the pros and cons of the different models.
